Accounting System

Under the modified accrual basis, Evergreen budgets and records income in the period income is earned and budgets and records expenses in the period expenses are incurred. Evergreen capitalizes fixed assets, when appropriate, in compliance with GAAP. Reporting systems follow the same GAAP methods. Evergreen completes payroll and associated State and Federal payroll tax reporting. Accounting practices integrate with the PA State Chart of Accounts. Quickbooks, the accounting software, allows Evergreen to create and change the account structure as PDE modifies the Chart of Accounts.
