Director's Report

Jill reported the following:

School status: Fourth week ends next week, and progress reports will be submitted. 90% of students are on track and about 5% are lacking. Is this due to tech or supervision? This process has been tough on teachers. It is a large learning curve, but all are trying their best. We dealt with a power outage and it was a real inconvenience! School attendance is at 100 students. Jill's concern is virtual. What if students stay virtual? Do we keep the virtual option?

<u>Health and Safety</u>: Temperatures are being taken and student mask wearing is at 100%. A senior stayed home due to a cold. Another student traveled to Alabama to watch an Air Force Academy graduation and then quarantined for 2 weeks.

<u>Grant</u>: Covid 19 grant has been spent. (\$90,000) Thank you to the Foundation for fronting the money until it is received in October-November. It was used to purchase 125 Chromebooks, TV's, document cameras, and printers.

<u>Halloween</u>: We will not participate in this years Halloween Parade, which was advised by the school nurse.

Finance

<u>Grant:</u> SRSA Grant was received in August. \$26,000 for essentials and technology including books/toner/new textbooks.

<u>Budget:</u> Completed and submitted to PED at the end of September and was signed by Mary Ann Lewis.

Recommend new textbook purchase for advanced classes. This may be a good year to update various methods of delivering curriculum.
