- 1. Call to Order by President Joanne Storer called the meeting to order at 7:08 PM.

- 4.1. Chief Executive Officer and Director of Evergreen Community Charter School Jill Shoesmith
 - Report given verbally
 - Jill reported that the parking lot paving has been completed and the paperwork has been submitted and approved by the PMSD Building Superintendant to process payment. Jill noted that the school saved \$20K, spending only \$107K on the project due to overestimating the amount of fill material. She also noted that the Foundation hired a Project Supervisor for \$800.
 - Jill reported that the State budget is not officially passed however an agreement has been reached. PMSD still has August and September invoices outstanding. They send 50 students out of the total of 77 students currently at Evergreen.
 - Jill announced that Evergreen has received a Rural School Technology Grant for \$18,366. The school will replace laptops and add classroom laptops. Jill also reported that Evergreen has increased their internet bandwidth through ProLog for and additional \$10

to \$15 per month.

- Jill reported to the Board that the faculty understands the Board's decision to defer raises until the state budget issues have been resolved. She reported that the staff maintains a good morale.
- Recently the 6th, 7th, and 8th graders visited Millbrook Village for an Orientation for the annual Spring Project
- Jill reported that the school has received generous donations in memory of Dillion Corcoran.
- Jill reported that the start of the school year was better than imagined. The older students were very welcoming for the new students.
- A Parent's Meeting was held on September 9th and was attended by 45 to 50 people. The meeting went well.

It was decided that Mary will call PennStar as per Holly's suggestion since Evergreen already has an established banking relationship with them. It was decided that the Board would be looking for a \$210K to \$250K line of credit. Mary will continue to pursue and if needed, a vote can be held via email.
